Monitoring Requirements Not Met for HAMLIN WATER COMPANY PWS 2640044

Our water system violated one or more drinking water standards over the past year. Even though these were not emergencies, as our customers, you have a right to know what happened and what we did to correct these situations.

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. During _____ we failed to monitor for the following contaminants and therefore cannot be sure of the quality of our drinking water during that time.

What should I do?
